Money Receipt will be issued to the student by the college after verification of the account. The receipt may be collected from the college office by hand.

- 13) Refund shall be made after the end of the session for each section, if any.
- 14) No refund will be made if the students leave the course in between any time of the session.
- 15) Fee structure might be change according to the need and requirement of the students.
